PURPOSE: To provide assistance to American Indian and Alaska Native (AI/AN) federal employees holding Term, Seasonal, Career Conditional, Career appointments and full-time federal contract employees to attendance the SAIGE National Training Program (NTP).

SAIGE NTP Conference Scholarship – Subject to the availability of funds, scholarships will be awarded for attendance to the SAIGE Annual NTP. Scholarship will include registration, travel and lodging for attendance to the SAIGE NTP conference.

ELIGIBILITY

* Permanent, term, or career seasonal Career Conditional, Career Federal and full time federal contract AI/AN employees who are members of SAIGE. Previous awardees are not eligible for this scholarship. Individuals who have been awarded this scholarship are not eligible to apply again.

APPLICATION REQUIREMENTS

Complete and submit the attached application package to the SAIGE and include the following:

- Letter of Recommendation (character reference)
- * Narrative of SAIGE and community service involvement
- * Essay Topic: Describe your educational and workplace career development goals and how this scholarship will assist you in meeting these goals.

AWARD REQUIREMENTS AND DISBURSEMENT:

For SAIGE NTP scholarship, SAIGE will pay for travel, lodging at the host hotel and conference registration fee. Arrangements will be made for the recipient prior to the National Training Conference.
